The Answer to How


? How do I become healed of this hurt? ?? How do I free myself from my hang-ups? ??? How do I overcome all my harmful habits?

As Christians, we believe we need God to be saved. Still, after that, we're convinced we can handle everything by ourselves. How silly are we? As we say at Celebrate Recovery, if we could fix ourselves, by now, we would have. But we can't. It is impossible. And, God doesn't expect us to white-knuckle it and do it all by ourselves.

Listen to Jane, a C/R member, tell her story. A story about the "aha" moment when she realized how she was successful in surrendering her eating disorder.

The way I've had victory is by NOT doing any of the things I have done before. That is extreme dieting, starving, or exercise, followed by stuffing and losing control, followed by sheer hopelessness and feelings of shame and failure. The way I've reached my goal is by crying out to the Lord, again and again. Every time I face a portion of food or a situation that has the power to trigger me, I ask Him to help me. To help me handle it without my drug of choice – food. I ask Him to rescue me AT THIS MOMENT from THIS TEMPTATION.

Recently I asked God why I am now struggling with emotional vulnerability. I am not sure how to deal with the fear of being emotionally hurt, betrayed, or being attacked again. I know this is the next issue He wants me to deal with. I asked how can I possibly overcome the fear? The answer; He said the same way you overcame your eating disorder. So I went back to the first three steps of CR and found that every time I face temptation, my only hope is to reach upward in prayer.



Romans 7:18 I know that nothing good lives in me, that is, in my sinful nature. For I have the desire to do what is good, but I cannot carry it out.

Step 2: We believe that a power greater than ourselves can restore us to

Philippians 2:13 For it is God who works in you to will and to act according to His good purpose.

Step 3: We make a decision to turn our wills and our lives over to the care of God.



Sue Eggleston called the meeting to order at 7:32 pm

Angie Dillon led devotions.....Different responses to the world situations...fear, disregard, and others. "Our Faithful Teacher" by Charles Stanley.

May 2020 minutes were approved by consensus.

Ministry Reports

Kinckle Robinson (Finance).....We are holding our own in regards to finances. Just slightly behind in receipts vs. expenses. Money designated for parsonage renovations have been spent. Paid building loan down to \$152,789.

Angie Dillon (Day Care).....MDC is doing great! Now are following CDC guidelines. Have been averaging 50-60 kids per day, whereas normally they have about 100. Nancy believes that number will climb. An administrator from APS called and asked if MDC could help if schools had to implement an A-B day type schedule.....this would involve hiring more workers and charging fees. Graduation was held in Courtland Field on June 16th. (Due to rain, graduation was held in Legacy Hall.)

Dan Turner (P & G).....Parsonage renovations are nearing completion. Water usage in main church building has dropped dramatically, Dan is convinced there was a meter issue resulting in high usage earlier in the year. AC is turned on in sanctuary and Legacy Hall and set higher to keep humidity stabilized. Suspended Cintas for the month of April, and just started a limited service in May.

Doug Webb (SPRC).....Norman Ramsey will move some furniture into the parsonage on 6/27, and could use some volunteer help. Russell and Julie moved out of parsonage on 6/21. Pastor John Flood will be handling pastoral needs until Norman is here on 7/2.

Harry White (UMM).....The 4th of July cookout has been cancelled.

Sue Eggleston (CC Chair).....Brought up that Nancy Dawson said we pay \$500 per year for offering envelopes, which some people don't use and the money counters said are cumbersome to deal with.....do we want to order? Will table this issue until next month. There is a safety deposit box for MUMC at Farmers Bank that has some documents in it, not sure what they are. Kinckle will call Farmers and remove Janet McConville's name from safety deposit box access and add himself, Nancy Dawson, and Tom Hall. (Instead of Tom Hall, we left Rodney Deaner on the list as he is a trustee.) The reception held for Julie and Russell was a big success.

Cindy Ranson (Day Care).....Need a copy of lease between Day Care and MUMC to help fill out paperwork for the government loan to be forgiven. Not sure if such a lease exsists. Doug Webb will talk to George Bergdoll about this.

Russell Cheatham.....He and Julie want to thank everyone for their time here. They love us and will miss us.

Rodney Deaner closed with prayer.

Meeting was adjourned at 8:11 pm.
